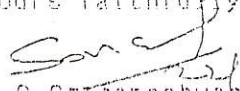

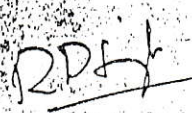
The Council may inspect/visit the Institute any time it may deem fit to note progress/compliance.
